

**2024 Blue Shield and Kaiser Summary Plan Booklets** are now available in MemberPlus for agencies that offer these medical plans through SDRMA. From the Health Benefits landing page select Health Benefits Documents and select Blue Shield and/or Kaiser Plan Documents. Anthem Blue Cross Summary Plan Booklets will be forthcoming.

**Anthem - Move to Medicare** - is available to all participants enrolled in SDRMA Anthem medical coverage. "Move to Medicare" (M2M) is an Anthem sponsored service designed to support individuals nearing the age of Medicare eligibility. The program is very simple: it helps individuals to experience smooth transitions from active coverage to Medicare when the time is right and there is no additional charge. To access the flyers for M2M log into <a href="MemberPlus">MemberPlus</a> and from the Health Benefits landing page select Health Benefits Documents, select Anthem Flyers and select Move to Medicare.

**2025 Required HDHP and HSA Plan Updates** - To maintain compliance moving into 2025 the following changes will be made to HDHP plans and HSAs.

**HDHP 10** plan **calendar year deductible** will be increased to **\$1,650** individual coverage and **\$3,300** family coverage (up from \$1,600 and \$3,200 in 2024).

HDHP 20 plan maximum out of pocket will be increased to \$6,200 individual coverage and \$12,400 family coverage (up from \$5,950 and \$11,900 in 2024).

**HSAs** annual limit contributions for individuals with self-only coverage under an HDHP plan is \$4,300 (up from \$4,150 in 2024). The limit for individuals with family coverage is \$8,550 (up from \$8,300 in 2024).

## Blue Shield - Network Updates - Potential Terminations - Multiple Providers

Blue Shield avoided the impending Providence Health Systems termination and a new contract agreement has been tentatively reached. The new agreement works to ensure Blue Shield members have continued in-network access to their Providence doctors, clinics, and hospitals.

Meanwhile, Blue Shield continues to negotiate with other providers. Below is an outline to help keep you informed of the latest. We will continue to monitor with Blue Shield and provide updates as negotiations progress:

**SaveOnSP** for Blue Shield and Anthem medical plans has an updated drug list effective July 1,2024. To view the list log into MemberPlus and from the Health Benefits landing page select Health Benefits Documents, select Plan Specific Flyers and select Express Scripts - Save on Specialty Drug List.

**Voya** has changed their funeral vendor from Everest to **Empathy effective 4/1/2024** for Will Preparation and Funeral Planning value added services.
