SDRMA is excited to announce a new supplemental pharmacy benefit option effective January 1, 2025, for generic maintenance medications, **Rx'nGo!** This new pharmacy benefit option provides a 90-day supply for certain generic maintenance prescriptions and insulin products/needles/syringes for Blue Shield and Anthem Blue Cross plans at **\$0 copay and \$0 shipping!**

# Update for HDHP Only: Access to Care before ID Cards received Flyer for Blue Shield HDHP Pharmacy Mail Order and Pharmacy – Humira Biosimilar

With Blue Shield HDHP plans moving to Amazon Home Delivery for mail orders effective January 1, 2025 the Blue Shield Access to Care before ID Cards received flyer has been updated to reflect updated prescription information under "Important Pharmacy Benefit Information, HDHP Plans". The update flyer is located in MemberPlus on the Health Benefits landing page: Health Benefits Documents>Plan Documents>Blue Shield Plan>Access to Care before ID Cards Received.

A new biosimilar for Humira, the world's best-selling drug, will be available at \$0 copay for SDRMA HDHP plan participants starting 1/1/2025 as part of the launch of Blue Shield's Pharmacy Care Reimagined model. Blue Shield collaborated with Fresenius Kabi and Evio Pharmacy Solutions to purchase FDA-approved Humira biosimilar for \$525 per monthly dose, compared to the market reported net price of Humira at \$2,100.

This collaboration will bring drug spending down for HDHP participants. Adherence for the medication is expected to increase, benefiting the overall cost of care and, more importantly, member health outcomes. More details about Blue Shield's Pharmacy Care Reimagined can be accessed **here**.

HDHP participants with existing prescriptions for Humira will be encouraged to switch to the biosimilar. However, if their provider continues to prescribe the brand



name drug, it will be covered according to the plan benefit.

Any new prescriptions issued for brand name Humira on or after January 1, 2025, will require a medical exemption approval submitted by the provider. If the prescription is not approved through this process, the member will be responsible for the full price of the drug.
