2025 Open Enrollment – Now Closed

The Open Enrollment period, which ran from October 1 to 31, 2024, has now closed. If employees did not make any changes, their current coverage will automatically carry over to the 2025 program year, with no further action required on your part. Any updates made during Open Enrollment will be reflected on the January 2025 benefits invoice, available on MemberPlus around December 5.
