The February Medical and Ancillary billing is now available in **MemberPlus** as one single invoice with all benefits combined. Friendly reminder that *payment is due in full by February 22, 2025*.

To view your agency's invoice, please log into **MemberPlus** and click on *HB Invoices* from the Health Benefits landing page. *ACH Payment Processing* instructions can be found in the portal. For your convenience, a link to download the combined invoice and/or export the invoice is also available.

2024 Medical 1095B Forms

On December 30, 2024, SDRMA emailed the 2024 medical 1095B forms to agencies (if the email sent on December 12 indicated that, based on your medical plan offerings, SDRMA would provide them). If your agency received 1095B forms, please review them for accuracy. Any discrepancies must be reported to us by **February 14, 2025**. Medical, Dental, and Vision ID Cards

If your agency offers dental and/or vision through SDRMA, ID cards are only available electronically online or via the Delta Dental and VSP mobile apps. Please click [here](#) for more information.

To obtain Delta Dental ID cards, register online at www.deltadentalins.com and create an account. Once logged in, you can print ID cards, review claims, find providers, etc.

To obtain VSP ID cards, register online at www.vsp.com and create an account. Once logged in, you can print ID cards, review claims, find providers, etc.

Centers for Medicare & Medicaid Services (CMS) Disclosure Reporting - Reminder

On January 6th, SDRMA sent an email to agencies who offer medical coverage through SDRMA to complete Centers for Medicare & Medicaid Services (CMS) Disclosure Reporting. This was to be done within 60 days of January 1st (even if your agency doesn't offer Medical Medicare retiree coverage through SDRMA). Please complete the report as soon as possible, following the instructions outlined in the January 6th email.
