2025 Kaiser Permanente Senior Advantage (KPSA) Rates

KPSA rates are guaranteed until January 1, 2026 and a rate increase for plans will be effective January 1, 2025 at 7.65%. If you are an agency who offers KPSA retiree coverage, please refer to the note on page 16 of the brochure about KPSA service areas/regions to ensure your future retirees are eligible to enroll in a KPSA plan *prior to* submitting the enrollment to SDRMA. You can also refer to the *KPSA Process* document located in **MemberPlus** on the *Health Benefits Document* page, under Kaiser-specific documentation.

2025 Concern+ First Responder Renewal - Effective January 1, 2025

The 2025 Concern+ First Responders rates (guaranteed until January 1, 2026) are in and due to higher-than-expected utilization and pent-up demand, has brought the rate in at an increase of 28.6%. As a reminder, these rates are only applicable to agencies that offer the Concern+ First Responders benefit and apply only to employees classified with SDRMA as First Responders.

VOYA Long -Term Disability Benefit - Additional Plan Options

Effective January 1, 2025, SDRMA will offer additional options for VOYA Long-Term Disability (LTD) plans (Option 3 and Option 4). The new plan options have an increased monthly maximum benefit of \$10,000! For plan/rate information, refer to the SDRMA Health Benefits brochure.

- Page 28 lists options/rates for agencies that have 10 or more employees
- Page 29 lists options/rates for agencies that have less than 10 employees
